### **Course Description**

This course will focus on the *Civil Liberties* of individuals as they are enumerated in the United States Constitution. In particular we will explore in greatest detail the First, Second, Fifth, and Ninth Amendments, and their application to the states through the 14<sup>th</sup> Amendment. Thus, this class will explore constitutionally provided property, economic, expressive, religious, privacy, and equal protection rights of United States citizens. This class makes use of the <u>case studies method</u> to explore the dynamic process used by the United States Supreme Court to interpret and change the meaning of individual liberties over the years. Students will exit the course with the knowledge of how individual civil liberties are interpreted and upheld in America today.

# In class quizzes

Throughout the semester you are asked to read, comprehend, and comment on numerous seminal Supreme Court decisions. Occasionally class will begin with quizzes over the readings or specific cases that are assigned for that day. These will **not** be lengthy, taking place within the first 5 minutes of class. There are no makeup quizzes given, so come to class and be prepared. All total, these quizzes are part of Attendance and participation which collectively will make up 100 points of your final grade (20%)

#### **Case Brief Assignment**

Students in this class will practice the art of creating case briefs that accurately summarize 5 unique cases from our readings. I will distribute an example of what a completed case brief looks like and students will select 5 cases they find most interesting and turn in a completed brief for each of those cases. This assignment is worth 100 points total. Note that early drafts may be submitted for instructor feedback at any time, but the 5<sup>th</sup> brief must be turned in by 11/11/2021. All briefs should be in standard format, 12-point font, double spaced not more than 4 pages total per case and MUST CONTIAN PROPER CITATIONS. More details will be given about this assignment in class.

#### **Attendance and Participation**

I strongly encourage you to attend class. Attendance will not be taken in this course on an everyday basis, yet I will pass an attendance sheet on randomly determined days, and I reserve the right to do so on any additional days as well. This course is a seminar relaying on the case studies method of exploration; accordingly, I will keep tabs on who participates in class discussions and how often. Your attendance and participation grade are worth 20% of your total grade in this course. Thus, if you want to do well in this class it is imperative that you attend regularly and contribute meaningfully to the class discussion.

#### **Cheating and Plagiarism**

Cheating is wrong, and I do not like it. If I catch you cheating (e.g., looking at someone else's paper during a test or quiz, consulting notes during a test), I will punish you. Cheating carries with it a severe penalty, and may even lead to expulsion from the university, so do not cheat! Cheating on an exam will lead to an automatic score of zero (0) on that exam without exception.

I will not tolerate plagiarism. According to the Merriam-Webster Online Dictionary, to "plagiarize" means:

- o to present as new and original an idea or product derived from an existing source.

In other words, plagiarism is an act of fraud. It involves both stealing someone else's work and lying about it afterward. If you have questions about plagiarism, please see me BEFORE you turn in work that you are unsure contains proper citations.

#### Reading:

This class will require an ample amount of reading on the student's part. Coming to class prepared to participate will involve daily reading of the assigned text chapter or case opinions. You will be tested over the reading, and you will need to have completed the reading in order to participate in that session's discussion. Doing well on pop quizzes will be quite challenging to students who are not prepared for class. In short, I simply cannot envision a way for you to do well in this course without completing the readings as assigned. Note: if it is in your book or any outside reading that is otherwise assigned, you may be tested or quizzed on it.

#### Talking in class:

This class will involve a great deal of discussion. However, you are to speak *only when recognized by me*. Furthermore, you may NOT talk when someone else (including me) is speaking. Additionally, let us also remember that disagreements are natural when discussing some of the topics of this course, yet we must remain civil in our discussion at all times to foster intellectual development.
