Assignments:

These will be in the form of written reaction papers. Each will be 2-3 pages in length

following the criteria of 12 font, Times New Roman, double spaced with citations if needed. They will be due on Fridays (dates are marked on the assignments in D2L) by 11:30 pm of the corresponding day.

The final will be a written research paper on the historical topic of your choosing. Instructions for the final or located in its corresponding section in content on D2L.

PLAGIARISM AND ACADEMIC DISHONESTY POLICY: “Cheating and plagiarism are violations of Ethics of Social Responsibility—one of the outcomes that has been identified as essential to the Civic Arts. - c. Presenting as your own the creative work (for instance, music or photographs) of another without proper acknowledgment. Besides plagiarism, other forms of academic dishonesty include the following:
- d. Submitting the same work in two or more courses without significant modifications or expansion and without the approval of the instructors involved.
- e. Submitting purchased, borrowed, copied or specially commissioned work as if it were one’s own.
- f. Knowingly permitting others to submit your work under their names.
- g. Copying the work of others during an examination or other academic exercise.
- h. Knowingly allowing others to copy your work during an examination or other academic exercise.
- i. Using “cheat sheets” or any other unauthorized form of assistance during an exam, quiz or other academic exercise.
- j. Manipulating or fabricating data to support erroneous conclusions.”
