- Know how to conduct a forensic document examination research experiment that will enable application of research methodology in solving forensic problems.

- Prepare case reports in a variety of forensic document examination problems.
- Analyze, compare, and evaluate questioned documents using accepted standards, terminology, and methodology.

Assessment

Your progress in this class will be assessed through a combination of case report assignments, reading and reaction discussions, and formal papers. There are 100 possible points in this course.

Assignments

<u>Curriculum Vitae (CV)</u>: The student is to prepare a curriculum vitae that outlines academic, work, and professional experience. The CV assignment is worth 4 points.

<u>Case Reports</u>: There are six case reports due in this course. Instructions regarding case report preparation and the materials needed to examine the case reports will be posted by the instructor in the Content section of D2L. Each case report is worth 8 points.

Reaction Paper: The writing assignment is a reaction to a critical article on forensic document examination. The student will be expected to prepare a 4-5 page reaction paper (excluding cover page and references) to the critical article which will be posted in the Content section of D2L. The paper must be formatted in APA style. The student is expected to make an argument against the points made in the critical article and support his/her position through citations of supporting literature. The reaction paper is worth 8 points.

OFFICIAL SYLLABUS WILL BE PROVIDED IN THE COURSE

Research Paper: The final research paper is the report of a forensic document examination (FDE) experiment conducted by the student. The subject of the experiment can be on any topic relevant to FDE. The research report must include 1) a clear thesis statement and introduction to the topic; 2) literature review; 3) methodology; 4) results; and 4) discussion and conclusion. The research paper must include a minimum of five citations from scholarly sources (peer-reviewed journals and/or academic texts) and formatted in APA style. The paper must include a cover page, abstract, reference pages, and 8 to 15 pages of text. The research paper is worth 20 points.

<u>Discussion Questions</u>: Cumulatively, discussions are worth 20 points. Discussions are expected to be meaningful, well-developed paragraphs in response to the discussion topic(s) posted by the instructor. The student needs to submit a minimum of one major reaction to the posted discussion and at least two responses to other students in order to earn maximum points.

Assignments can be submitted to the instructor through the "Dropbox" on D2L. If there are technical issues, I will allow submission of assignments via email but this method needs to be kept to a minimum. You may use MS Word or PDF for assignments. A letter grade will be deducted for each week that an assignment is submitted late.

Course Policies

Attendance & Participation

Students are expected to actively and regularly participate in online discussions every week. Participation is worth 20% of the overall grade and the participation grade will be posted at the end of the course. Online participation will include reactions to assigned reading materials and discussion of topics introduced by the instructor.

Academic Writing & Research

All formal papers are expected to be written in a formal, objective, and scholarly manner. Citations must come from academic sources (peer reviewed journals and academic texts). Use the ETSU online Sherrod Library link to find research citations.

All formal papers and citations must use the style published in the *Publication Manual of American Psychological Association* (6^{th} ed.). Referred to as APA style, it is widely used in the social sciences. In addition to the manual, there are several resources on the Internet about use of APA including:

If any student is caught cheating or plagiarizing on any part of the course requirements, that student may be given an F for that particular assignment or for the entire course, at the discretion of the instructor. Any student caught cheating or plagiarizing may also be reported to the Dean.
